- ii <u>Ward Councillor Mr G Ioannou</u> reported: on local Highway issues ECC Highways Investigation into speeding issues on northern Stambridge roads has been held up by Covid-19.
- iii Ward Councillor Mr S Wootton reported: He has been heavily involved with issues arising from the Lockdown and its effect on the RDC including: Financial shortfalls of some £630,000 potential at the end of this financial year—Issues with the NHS Primary Health Care the Community Hub and Business Grants has focussed his attention General Waste collection has increased some 35% over this last year due to people working from home, etc To date the waste collection and street cleaning service has a total of 62 staff, of which 22 have reported sick or in isolation, so some collection delays are inevitable.
